

## Message from the President - Kristin Enns-Kavanagh

Dear Members and Friends of Heritage Saskatchewan:

It has been another busy year for the board of directors of Heritage Saskatchewan!

Our work towards building a strong voice for heritage in Saskatchewan has progressed well over the past year and it is rewarding to feel that we are starting to "pick up steam" as an organization. However, there is still much to do!

One of our board's most significant accomplishments this year was developing Heritage Saskatchewan's Ends statements. Ends statements clearly define the result, change or difference that will be made by an organization's activities and who that change or difference will benefit.

Our two Ends statements are

1) **Saskatchewan peoples' lives are strengthened and enriched through our diverse heritage legacy;** and

2) **Saskatchewan has a cohesive, vibrant and sustainable heritage community.** These Ends statements provide an essential "compass" to guide board decisions, and have already proved their value in board discussions. The board developed these Ends in June of 2011 with the help of Linda Fast, a peer governance facilitator who strongly believes that good board governance builds successful organizations. As a result of her commitment to governance, Linda has generously donated a great deal of time to helping the Heritage Saskatchewan Board, and for that we'd like to extend our sincere thanks.

This year, we have made several other significant inroads into building a strong organization. Our ongoing work on developing governance policies is



proceeding well. We are now looking forward to the time when our regular policy monitoring work will be part of an efficient routine that frees the board up for other important work, such as staying connected with the membership.

In December 2011, we held a workshop, again with Linda Fast, in which the board learned the basics of conducting successful ownership linkage and began a plan for conducting ownership linkage activities. This work will continue in the coming year. Our final set of bylaw revisions is now complete and will represent the last major changes to the bylaws for some time. Finally, the board reviewed membership fees this year and opted to reduce them. We feel that this promotes a more inclusive organization and puts greater priority on building the strongest possible voice for heritage.

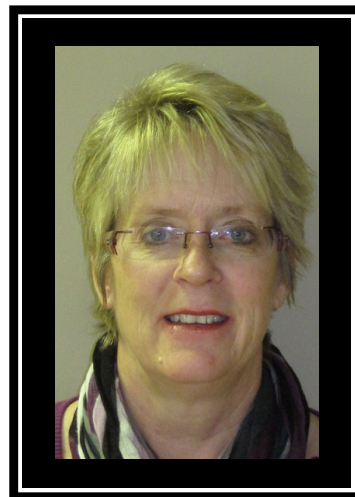

It's hard to believe that another year has gone by and that it is time once again, to gather together for our Annual General Meeting and Forum. This past year was defined as one of growth and development and what a year it has been!

The Board of Directors remains committed to building a strong, firm foundation and spent time developing ENDS statements to guide the organization. From an operational perspective, the development of the ENDS has provided the compass from which our strategic and operational plans have been developed. In addition to the operational plan, efforts have been directed in creating internal policies and procedures to build a base that ensures success of the organization. Staff spent time creating strategic priorities to address the ENDS, focusing primarily upon **building awareness** and **building community**. This work will continue to be a priority over the next few 'formative years', in addition to addressing directions in our external environment.

Advancements in raising awareness about heritage and our organization were initiated and included the development of key messages, position papers, a successful MLA reception, a Provincial election campaign strategy, participation at tradeshow, conferences and workshops, establishing a presence on Twitter and Facebook, upgrades to our website, and expansion of the distribution of our electronic newsletter *Heritage Happenings*, to name but a few. These initiatives not only contribute to increased awareness for the organization but more importantly, raises the profile of our diverse heritage.

Following an evaluation of our operations, a decision was made to disband the working group structure and replace this with ad hoc operational committees. This new structure will address our current priorities and strategic objectives more effectively, and will offer volunteers more flexibility to dedicate the time they feel that they can to



specific tasks. I would like to take this opportunity to thank all who volunteered with the working groups in the past, and encourage anyone who may be interested in volunteering in some capacity in the future, to contact our office.

Two committees that are active include the Database and Advocacy Committee. The Database Committee has been actively engaged in creating a registry of funding resources available for heritage. In the future, Heritage Saskatchewan plans to move this information into a searchable database format, housed on our website. This list provides an analysis of organizations currently providing funding and identifies where there may be critical gaps as we build support for heritage in Saskatchewan. Secondly, the Advocacy Committee has been very active and it is through their guidance that several of our position papers, our election strategies and other initiatives have been discussed, and scrutinized prior to distribution and implementation to a number of audiences. I would like to thank each member on the Database and Advocacy Committees for their dedication to moving the heritage agenda forward.

In addition, thank you to our members and their networks who have supported and continue to support this organization and more importantly, for their dedication to raising awareness and conservation of heritage throughout this province.



To the Members of  
Heritage Saskatchewan Alliance Inc.

---

I have audited the accompanying statement of financial position of Heritage Saskatchewan Alliance Inc. as at November 30, 2011 and the statements of revenue and expenses and net assets for the year then ended, and a summary of significant accounting policies.

***Management's Responsibility for the Financial Statements***

Management is responsible for the preparation and fair presentation of these financial statements in accordance with Canadian Accounting Standards for Private Enterprises and for such internal control as management determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

***Auditor's Responsibility***

My responsibility is to express an opinion on these financial statements based on my audit. Except as explained below, I conducted the audit in accordance with Canadian generally accepted auditing standards. Those standards require that I comply with ethical requirements and plan and perform the audit to obtain reasonable assurance whether the financial statements are free of material misstatement.

An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the financial statements. The procedures selected depend on the auditor's judgment, including the assessment of the risks of material misstatement of the financial statements, whether due to fraud or error. In making those risk assessments, the auditor considers internal control relevant to the entity's preparation and fair presentation of the financial statements in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the entity's internal control. An audit also includes evaluating the appropriateness of accounting policies used and the reasonableness of accounting estimates made by management, as well as evaluating the overall presentation of the financial statements.

In common with many non-profit organizations, the association derives revenue from membership fees, donations and other fundraising activities, the completeness of which is not susceptible to satisfactory audit verification. Accordingly, my verification of these revenues was limited to a comparison of recorded revenue with bank deposits and I was unable to determine whether any adjustments might be necessary to revenue, excess of revenue, assets and net assets.

***Opinion***

In my opinion, except for the effect of adjustments, if any, which might have been necessary had I been able to satisfy myself concerning the completeness of the revenue referred to in the preceding paragraph, these financial statements present fairly, in all material respects, the financial position of the association as at November 30, 2011 and the results of its operations and its cash flows for the year then ended in accordance with Canadian Accounting Standards for Private Enterprises.
