

Message from the Chief Executive Officer - Ingrid Cazakoff



Where did the time go? As we complete another year of operation I find it hard to believe that it was only a year ago that we celebrated our 5th anniversary. Much has been accomplished and I look forward to what lies ahead.

This past year, much of our public awareness initiatives continued to be guided by our work identified in Living Heritage & Quality of Life: Reframing Heritage Activity in Saskatchewan, prepared for Heritage Saskatchewan by Sandra Massey. Connecting heritage to quality of life issues has provided

us with avenues to raise awareness and reframe our messaging that builds an understanding of the value of living heritage. Practical applications to incorporating this concept has created avenues for us to explore several new projects and partnerships.

Our research this year had Sandra Massey developing a number of articles in a series entitled "We Need to Talk" addressing the connections between living heritage and community development. In addition to the "We Need to Talk" series, a number of "Living Heritage at Work" profiles were developed further highlighting heritage workers within this framework. Those profiled included an educator, public engagement specialist, stonemason, recreation therapist, an artist and police officer. All of their stories address living heritage in their life and work. As we build upon opportunities to work with agencies and individuals from a broad range of disciplines, it is obvious that we share common interests and demonstrates connections between heritage and quality of life.

Another highlight resulting from our work has come through our involvement

with the Saskatchewan Ecomuseum Initiative (SEI). The SEI committee composed of representatives from the Royal Saskatchewan Museum, Museums Association of Saskatchewan, SaskCulture, Heritage Canada The National Trust, Raven Consortium and most recently, Nature Saskatchewan, have come together to encourage and provide advice, training and other needs to communities looking to establish an ecomuseum. The development of an ecomuseum, which combines 'nature and heritage perspectives to foster sustainable community' is strongly dependent upon the people living within a particular area, where heritage is not static, but evolving, renegotiated and nurtured by community. Interest in the development of ecomuseums and other communitybased approaches indicates that people do care about their communities and are looking at more holistic approaches growing and sustaining strong communities.

This past year marked the first full year that the Heritage Fairs program was operated and delivered by Heritage Saskatchewan. Over 2300 students in 100 classrooms participated in the program and we hope to keep that momentum going! A new addition to the program in 2014 included a number of workshops for students at the regional fair level, and feedback received from the participating teachers and students indicated that this was a welcomed addition. Along with workshops, we introduced an awards program at the Provincial Heritage Fair focusing upon specific methodologies including innovation, digital, historical thinking and archives. Thank you to those who partnered with us in the delivery of the workshops, to those who supported the awards program financially as well as to those who actively participated as



judges. We look forward to partnering and building upon these and other opportunities in the years ahead.

The Heritage Fairs program provided additional opportunities for students and Heritage Saskatchewan in a number of areas in 2014. For example, students who had completed their fairs projects on the First World War were invited to participate in an event at the Saskatchewan Legislative Building on August 4, as part of the World War I Commemorations. Seven students from communities including Regina, Saskatoon, Moose Jaw, Kipling and Meadow Lake showcased their Heritage Fairs projects. What a great opportunity for the students to participate and to meet a number of veterans and dignitaries present at the ceremony. Thank you to the Provincial Capital Commission and the Ministry of Parks Culture and Sport for including Heritage Saskatchewan and the students as a part of that event.

On the National level, Canada's History implemented a successful digital storytelling program offered to students across the country. In Saskatchewan, this project was piloted in Regina's St. Marguerite Bourgeoys School. Through leadership provided by Leanne Forrest and Dean Benko, Digital Learning Consultants for Regina Catholic Schools, and volunteer mentorship offered by Adrian Halter (Adjile Video Productions), students developed their digital projects that were then uploaded to the Canada's History website and the public was invited to vote on projects submitted from across the country. Two students from Saskatchewan were among the winners selected to attend a National Youth Forum in Ottawa on October 30 - November 2, 2014. This opportunity was one that the students and chaperones thoroughly enjoyed and I am pleased that this project will continue

to be offered through the Young Citizens Program of Canada's History until at least 2017.

There is always more to learn and do and finding the balance between new opportunities while simultaneously building upon existing ones is always challenging. Nevertheless, the work continues to be exciting and I am encouraged by the great work that I see happening throughout the province. I am encouraged by the support that has come from a number of people and organizations and consider it a great privilege to work with you as we raise awareness and support for heritage in Saskatchewan.

Thank you to the Board of Directors, who have volunteered their time to this organization, and who continue to inspire me through their insights and experiences. I appreciate your wisdom and guidance as Heritage Saskatchewan moves forward. Thank you to my staff, a great team, who every day provide me with the opportunity to learn from them and to work with them as we continue along this journey of exploration together.

Independent Auditor's Report

To the Members of HERITAGE SASKATCHEWAN ALLIANCE INC.

We have audited the accompanying statement of financial position of HERITAGE SASKATCHEWAN ALLIANCE INC. as at November 30, 2014 and the Statement of Operations, Statements of Unappropriated Surplus and Statement of Cash Flow for the year then ended.

Management's Responsibility for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with CPA Accounting Standards for Not-For-Profit Organizations and for such internal control as management determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

Auditor's Responsibility

Our responsibility is to express an opinion on these financial statements based on our audit. Except as explained below, we conducted the audit in accordance with CPA Accounting Standards for Not-For-Profit Organizations. Those standards require that I comply with ethical requirements and plan and reform the audit to obtain reasonable assurance whether the financial statements are free of material misstatement.

An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the financial statements. The procedures selected depend on the auditor's judgment, including the assessment of the risks of material misstatement of the financial statements, whether due to fraud or error. In making those risk assessments, the auditor considers internal control relevant to the entity's preparation and fair presentation of the financial statements in order to design audit procedures that are appropriate on the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the entity's internal control. An audit also includes evaluating the appropriateness of accounting policies used and the reasonableness of accounting estimates made by management, as well as evaluating the overall presentation of the financial statements.

In common, with many non-profit organizations, the association derives revenue from membership fees, donations and other fundraising activities, the completeness of which is not susceptible to satisfactory audit verification. Accordingly, our verification of these revenues were limited to a comparison of recorded revenue with bank deposits and we were unable to determine whether any adjustments might be necessary to revenue, excess of revenue, assets and net assets.

In our opinion, except for the effect of adjustments, if any, which might have been necessary had we been able to satisfy ourselves concerning the completeness of the revenue referred to in the preceding paragraph, these financial statements present fairly, in all material respects, the financial position of the as at November 30, 2014 and the results of its operations and cash flows for the year then ended in accordance with CPA Accounting Standards for Not-For-Profit Organizations.
